Notable Medical Negligence cases

Representing a daughter claiming on behalf of her late Mother's Estate in respect of negligent nursing home care, the latter failing to properly manage a known falls risk, resulting in a five figure damages recovery for her Estate.

Representing an elderly lady who received negligent hip replacement surgery from a Hospital Trust. Recovering six figure damages and also obtaining the approval of the Court to the settlement as the Claimant was diagnosed with Alzheimer's Disease, but nevertheless retained capacity resulting in a Coles v Perfect Order via the High Court.

Representing a husband and his children in connection with negligent paramedic care provided to his wife resulting in her death. Securing an admission of liability from the relevant NHS Ambulance Trust which is likely to result in a significant Loss of Dependency and Damages Award.

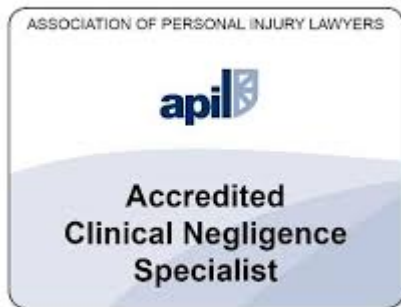
